

## Improving the Effectiveness of Your Scholarship Program for Strategic Impact

CIBOLO, TEXAS – Our many scholarship and student aid programs are one of our most significant contributions to the communities we serve. At every level of our organization, the seeds we sow are essential and welcomed contributions to the continued education of our young men and women in pursuit of a college education. In District 23, we reshaped our scholarship program with a strategic focus for greater impact. It is common practice that our yearly scholarship efforts rely on whether the members of our organizations have high school seniors as its vital source for applicants. There is also the common last-minute scramble of looking under rocks, so to speak to find a student to complete a scholarship application. When households run out of high school seniors, we dread the unpleasant report of we don't have anyone to apply. This is the result of a flawed practice, which time soon renders obsolete. This is also the result of our inability to change or consider alternative approaches to ensure continued participation in our programs. We just give up on it.

In District 23, DDGM Clifford Massey structured partnerships with Historically Black Colleges and Universities (HBCUs). Through these partnerships, the District established a goal of \$4,000 in continuing education grants. Funded by the District's PHAD23, Inc. 501(c)(3) non-profit organization, each grant is sponsored by a Lodge. District Focus (HBCUs): In the name of our "Redtails Scholarship", this grant in recognition of Tuskegee Airmen and Prince Hall Masons was established in 2020 at St. Philips College. This grant is sponsored by Granville C. Coggs Lodge 668, whose namesake Granville C. Coggs, a resident of San Antonio, was a Tuskegee Airman. We also have our "African American Studies Scholarship" with Texas State University.Established in 2021 at Texas State University in San Marcos for students pursuing coursework in African American Studies, this grant is sponsored by Pride of San Marcos Lodge 494. The District is currently organizing a partnership with Huston-Tillotson University. This new grant will besponsored by J. Washington Lodge 191.

Upon taking overall responsibility for the District Scholarship program, there was a definitive focus for the District. We could see the Lodges and Chapter subjected to the common experience of looking to find students who could apply. With so many scholarships available, there was a need for a more formalized process. A question of, how can we organize a professional, formal program to generate a pool of applicants and alleviate the dreadful scrambling of the Lodges and Chapter? How might we use strategic targeting within our District space to reach our more underprivileged and underrepresented areas? Formulating a strategic focus for the Lodge allowed us to sow seeds to purposefully expand the presence of our District.

Lodge Focus (Guadalupe, Gonzales, Caldwell, Hays, Wilson, Dewitt, Lavaca counties): District 23 has four Lodges located in Guadalupe, Hays and Caldwell counties. As you can see from this list, there are four other counties in our District. After some research, it appeared we had somewhat forgotten these other counties. Out of habit, because of where we are physically, we typically don't look any other way. Now, being the custodian of our program, it seems this presented a world of opportunity to expand our presence and sow a seed of Freemasonry in an effort to reach the entire geographic space of our District. All that was left to do was convince our Lodges of the opportunity, and structure a formal process which might cure our common ails, while achieving a strategic impact. In addition to the District's focus, each Lodge now provides its own direct scholarship to high school seniors across the District.

ESTABLISH A SCHOLARSHIP/STUDENT AID COMMITTEE – A committee of four should be sufficient. This committee should create the application documents and all other requirements. Establish a process and means to communicate and receive applications. Ensure applicants have a clear understanding of requirements to receive the award like college registration, enrollment verification and deadlines. We are often left with scholarship money because awardees forget to submit the closeout documents necessary to receive the check. Consider things like a committee email address, mock checks for presentations and a marketing flyer to highlight current and past recipients to publish later.

BUILD A LIST OF HIGH SCHOOL COUNSELORS – Build a list of counselor contacts for ALL the high schools across your District. You can *Google* your High Schools by counties and research the schools' and school districts' websites for contact information or call the school. For larger schools with multiple 12th grade counselors, pull maybe two contacts for that school. If you have several counties (with three or four high schools each) as with District 23, build this list a little bit at a time. BUILD YOUR EVALUATION CRITERIA AND STRATEGY – Do not become overly reliant on GPAs as this can be tricky. Some may make a case that those with 4.0 GPAs and high test scores have acquired multiple sources of scholarships already. You may even use a GPA range of say 2.5 to 3.5 to target students who you may think are likely to need the aid more than others. Please do your best with balancing this and not get fixated on one thing. In my case, my GPA and test scores where high and would have hid the fact that I was poor. A personal essay may tell the story though. Consider the strategic targeting of students in likely underprivileged and underrepresented areas as well. These areas are your small towns where Lodges are not physically located and counties to which you may not have an active presence. Areas of opportunities to for new Lodges.

ESTABLISH AN IDEAL PROCESS AND TIMELINE -

Structure a timeline and process based on your organization's application submission suspenses.

 September 1 - Send Scholarship Information to List of Counselors

September 1 to March 30 - Receive Applications (set hard deadline)

- April 1 to April 8 Evaluate Applicant Pool and Make Selections for Awards
- April 8 to April 15 Notify Selectees and High School Counselors
- May 1 to May 31 Conduct Presentations (maybe with School Award Programs)

 August 1 to August 30 - Closeout Activities for Disbursement of Award Check


SEND OUT SCHOLARSHIP LIST AND INFORMATION TO COUNSELORS – Send your list of scholarships and application forms out to every counselor on your contact list. Send this out in September. Set a February/March deadline for applications. This lead time is in line with the schools' plans for their senior classes who begin preparing for graduation at the beginning of the school year. If needed, adjust timelines to maximize the visibility of scholarships for all organizations. Especially if your Chapter, Council, Commandery, Consistory and Temple have scholarships. RECEIVING SCHOLARSHIP APPLICATIONS – With a lot of lead time from September to March, expect a lot of applications all the way up to the deadline. Build an Excel spreadsheet to list all the applicants and include things like school name, activities, GPA, intended college and major, and notes from essays. The committee should review all the applications and score for selection. Again, the selection and outcome of the awards should take into consideration things like most deserving, most in need, and the most strategic selection for the organization.

From the start, this process helped us to get organized and look like a professional fraternal organization. By the deadline, we had more than enough submissions to apply for any scholarship that would have come up between January and May. We had the ability then to utilize our application pool to match students with any other scholarships outside our District.

SELECTIONS – Once applications close in February/March, use the following week to conduct evaluations and selections. One way is the committee establishes and uses evaluation criteria to select the recipient for each award. Another way is to have each organization select an individual (from the list) that they would like to sponsor. If you have a struggling organization in an area, it may be beneficial to strategically award a scholarship or two in that area. Remember too, target students who are most likely in need, in underprivileged and underrepresented areas, and students attending certain colleges in the District's footprint. This goes a long way in helping organizations establish a presence and drive growth in an area. Inform the selectees and a schedule date, time and location for presentations. It is then easy to incorporate the Grand Lodge's J. T. Maxey Scholarship application into the process and identify what students will then compete for the Grand Lodge's scholarship.

Particular to this year, our selectee from District 23 won the top prize for our Grand Lodge's J. T. Maxey Scholarship of \$5,000. At the time of selecting Ms. Laney Osborne who attends Marion High School, we could not have anticipated this outcome. This selection, sponsored by J. Washington Lodge 191 was strategic in that Marion High School is an underrepresented area in our District. The selection decision by our Grand Lodge Scholarship Committee will likely have a far lasting impact on our presence in this community. For this we are grateful to the Grand Lodge and the scholarship committee. With the aid of the Grand Lodge, we know this is the beginning of something greater for our District and the community of Marion, TX. Ms. Osborne is featured in this issue of the Texas Prince Hall Freemason Magazine.

Our Pride of San Marcos Lodge 494 sponsors the District's partnership with Texas State University. With our large pool of applicants, Lodge 494 had an additional opportunity to select a deserving student for its Lodge's direct scholarship, who elected to attend Texas State University. This example of a strategic award would complement the District's HBCU partnership with the school. Due to limited awards, the Lodge's direct scholarship was awarded to Ms. Lyna Gonzalez, Steele HS located in Cibolo, who will be attending Texas A&M University and majoring in Biology and Chemistry.



Granville C. Coggs Lodge 668, the sponsor for our St. Philips College HBCU partnership is at the seat of District 23 in Cibolo, TX. This Lodge's direct scholarship was awarded to Ms. Alexis Barrera, Steele HS in Cibolo. She will be attending the University of Texas at Austin majoring in Political Science with a minor in Philosophy of Law.

PRESENTATION OF AWARDS – Set aside a date in May to do the presentations. Consider when schools do their awards programs. Inform the school counselors of the selection ahead of time to allow them to incorporate this into their programs. Having this listed in the schools' programs is another good way to establish a presence. A nice communityfacing or District event in May would be a great opportunity to connect with the awardees and their families. Bring out the mock checks and the cameras. The presentation is a great marketing tool for any community-facing article or newsletter. This is especially beneficial if you use public donations to support your program. And should make for a good Scholarship Committee Report. Ensure to follow up with the awardee on any follow-on verification requirements to receive their check.

From this process we were able achieve a greater economic impact than what we envisioned. We organized. We have partnerships with HBCUs to support their general scholarship funds, with a complement of individual scholarships from each of our Lodges. This professional process provided a pool of applicants in a volume sufficient enough to have applicants readily available to apply for any scholarship or student aid. We established a presence and relationship within all of our high schools, with the ability to strategically target underprivileged and underrepresented areas across our District. Here is an alternative approach for your scholarship program. This provides opportunity for greater economic impact across your geographic space, and avoids the common challenges of less effective practices. It is going to require some work to organize, but once it is set, you only need to press repeat.

## Granville C. Coggs Lodge No. 668 Participates in Child Abuse Prevention Month Event

CIBOLO, TEXAS - On Saturday, April 1, 2023, Granville C. Coggs Lodge No. 668 brothers and their families placed 849 pinwheels at Word of Life Church in recognition of National Child Abuse Prevention Month. The lodge teamed with Companions from **Roosevelt Tennessee** Royal Arch Chapter #148 and the Sorors of Gamma Alpha Chi Zeta Chapter, Zeta Phi Beta Sorority, Incorporated.



National Child Abuse Prevention Month recognizes the importance of families and communities working together to prevent child abuse and neglect. Throughout the year, communities are encouraged to increase awareness about child and family well-being and work together to implement effective strategies that support families and prevent child abuse and neglect.

The lodge partnered with the Guadalupe County Children's Advocacy Center (GCCAC), whose mission is to advocate for and provide services to children and families when there are allegations of abuse and neglect throughout the investigation, prosecution, treatment, and prevention of child abuse, and to reduce the trauma to children by coordinating a multidisciplinary approach. The GCCAC participates in numerous awareness events to help educate the community about child abuse and neglect and how to prevent it. The lodge has built a strong relationship with GCCAC and looks forward to a continued partnership.



There were 849 reported cases of child abuse last year in our community and probably three times more cases that were not. The pinwheels represented these cases and were meant to help raise awareness of this vital cause. This effort by the lodge is in line with the Most Worshipful Prince Hall Grand Lodge of Texas's mission statement, which states that its purpose is to provide service rendered to the people of Texas to improve their social conditions.

### Builds New Lodge Hall by Taking a Lemon and Making Lemonade

Temple, Texas – March 11, 2023 The new St. James Masonic Lodge No. 71 laid the cornerstone, cut the ribbon and dedicates its new lodge hall facilitated by Most Worshipful Grand Master Wilbert M. Curtis and a representation of the Grand Lodge. It was a culmination of three years of committed work by the brothers of St James Lodge No. 71, supported by the Temple Masonic Bodies and the Most Worshipful Prince Hall Grand Lodge of Texas.



In February, 2020, the City of Temple declared eminent domain on the then existing Lodge Hall, property and additional property across the street owned by the Lodge. Upon receiving the notice that the lodge hall was being acquired by the city, the brothers of St James Lodge met in a round table discussion meeting to consider our options. Some wanted to rent space in a building across town, some wanted to build in a new location, some even considered meeting in the AF&AM Lode Hall downtown. After all options were laid out on the table, the idea came up; "Hey, we have been given a Lemon, Let's Make some Lemonade"!

The question was asked, "*Why are we here?*" The answer to the question is found in our history. St. James Masonic Lodge No. 71 was organized and charted as a subordinate lodge under the jurisdiction of the Most Worshipful Grand Lodge, Free and Accepted Ancient York Masons of the State of Texas (known today as the Most Worshipful Prince Hall Grand Lodge Free and Accepted Masons of Texas) in 1891 by Grand Master Josiah

several years had passed, some property on South 8th Street (*now M.L.K. Jr. Blvd*) was donated to the lodge by Mrs. Sarah Dawson. In 1953 after having various fund raisers and borrowing \$5,000, a twostory hollow tile building was constructed, with the bottom space to be rented out. The membership continued to grow and was proud of this building.

Haynes Armstrong, the seventh Grand Master. Its chartered members were members of St. James United Methodist Church of Temple and the Lodge originally met at the Church, then on Ave. D. When the church moved to 12th

Street and Ave. C. so did the Lodge.

another Masonic Hall in a more desirable location and began fund raisers for this purpose. In 1969, more property was purchased in Southeast Temple near Old Taylor Road. The membership and funds continued to grow but so did the loan interest rates, so the lodge could not afford to build as the members had hoped. They had no choice but to be patient.

In September of 1982, the building, formerly St. James United Methodist Church became available for sale. The membership under the Master of the Lodge, Bro. Vernon L. Busby, finding the building suitable for its needs and with the cooperation of the sisters; Rising Sun Court #150, Heroines of Jericho and Carnation Chapter #37, Order of the Eastern Stars, it was decided to purchase the building for the Masonic Temple.

and watching the ceremony on the sidelines.)

At the dedication of that building, in November of 1984, Bro. Busby stated, "This is a delightful hour in the glorious history of St. James Masonic Lodge #71. As we look back over the road we have progressively traveled, we see that it has been straight and narrow, steep and stony, nevertheless through many toils and snares we have come praying and paying. May I hasten to say that we did not do it alone; this is the work of God and all the Glory belongs to Him."

With that being said, the cornerstone was laid by Grand Master Rueben G. White and the Grand Lodge Officers. (I was a Fellow Craftsman at that time. I was unable to participate in the ceremony and remember wearing a gray suit





After negotiations with the city. and receiving permission from the Grand Lodge. to sell the lodge hall, it was finalized in July. 2020 and the building vacated. Under the leadership of Bro. Ralph Godwin, Master of the Lodge, committees were assigned, and the work began. Thanks to the wisdom of the brothers past, the Lodge had purchased two adjacent lots in addition to the lot that the lodge hall sat on and one additional one across the street down through the years. In lodge hall August. 2020 the was demolished.



A contract with the Architecture Firm was signed in November, 2020 to create building design plans. On October 20, 2021the lodge voted to accept the building design. The lodge applied for a commercial loan on November 11, 2021. An agreement was signed with the general contractor in December, 2021 and work began in January 2022.

St James Lodge No. 71 broke grounds at the new building site on January 9, 2021. Representatives from all bodies were present along with contractors, loan officers, architectures and brothers from GLofTx local lodges.



After many delays and setbacks the building was ready for occupancy in March of 2023 at which time the cornerstone and dedication ceremony was performed in Grand Style.

With all assembled in front of the building, commencing at 9:00am, the Lone Star Grand Commandery Knights Templar escorted the Grand Lodge Officers, the Master of the Lodge Gaylon Sandles, St James Lodge No. 71 officers and Grand Master Curtis to the north-east corner of the building.









At the completion of the ceremony, Master of the Lodge Sandles, presided over the ribbon cutting ceremony, with the heads of the Temple Masonic Family cutting the ribbons; Rising Sun HOJ Court No. #150, Shiphrah Chapter #47, Vernon Busby HRAM Chapter #147 and Ed Blair Consistory #286.



All processioned into the Lodge Hall where a representation of the Grand Lodge processioned in to consecrate and dedicate the Lodge Hall for its purposes. Grand Master Curtis conducted the ceremony.





A proclamation was read from the City of Temple, Tx by Mayor Pro-Tem Judy Morales. Special Guest in attendance Temple **Branch** NAACP were President Grant, Wheatlev Zoe Alternative School Principal John **Pleasant, Leaders of several Churches** of the community that supported the Lodge by making their facilities available for meetings and other activities while the building was under construction.





The Temple Branch NAACP donated a tree to St James Lodge No. 71 for being a Life Member of the Temple Branch Other Masonic Leaders present were MEGHP Michael Berry, GTIGM Charles Lilley, Dep. of Orient for Texas, SGIG Elvis Irby and representatives of the Adoptive Bodies Head of Houses . Bro. Verdell Canady, the oldest living member of the Lodge and who was instrumental in the lodge purchasing the property on Old Taylor Rd in 1967, and who later help secure the loan for the building purchased in 1984 was recognized and received a rousing standing ovation. He still meets and exceeds his financial obligation to the Lodge and Texas Prince Hall Freemasonry!

Brothers from around the State came and participated in the dedication of the Lodge Hall.



Finally, to answer the question: "*Why are we here?*" Its because St James Lodge No. 71 has been a part of, and has supported the East Temple Community, since its inception in 1891. I believe that it is the only Black Community minded non-profit organization in the city of Temple, other than predominately African American Churches that owns its own building. It sits right in the middle of the newly designated African American Churches Historic District which includes Eighth Street Baptist Church, Wayman Chapel A.M.E, and Corinth Missionary Baptist Church. It still takes part in the Adopt a Street program. Not to mention the continued food give-away programs and student scholarship stipend programs.

With the city revitalization program that has demolished many buildings, both residential and commercial on Ave C., it is the only organization (at the writing of this article) that has built/rebuilt on the east side of Martin Luther King, Jr. Blvd. It continues to support several elementary schools on the east side in addition to providing extra support to Wheatley Alternative School, which is a block just south of the building. The Wheatley Alternative School staff has been one of our staunch encouraging supporters. TISD School administrators stopped and thanked us for remaining in the neighborhood, while we were still under construction.



## <u>2023 Winning District Essay</u>

I support the United States Supreme Court's reversal of the landmark court case Roe vs. Wade. Most people would believe that I take this stance because I am a God-fearing Christian, and while this is true, I also support this reversal because it gave each state its constitutional rights back. This is because the Supreme Court's ruling permitted each state to decide whether abortion would be legal in its own state.

I am in favor of this ruling for two primary reasons. Firstly, I believe that unborn babies have the right to life regardless of their fetal age. Secondly, I believe that the Constitution must be honored in all legislation, and for the past fifty years, it had not been. This fact is supported by Justice Samuel Alita in his quote, "It is time to heed the Constitution and return the issue of abortion to the people's elected representatives." Abortion is not like other contraceptive devices that can be classified as healthcare. In reality, it is medically condoned murder. Many Americans raised unsupported concerns about potential limitations on healthcare options. However, I believe that Christians should be focused on finding solutions, such as adoption, that negate the supposed need for abortion.

I believe that it is my personal responsibility to research topics beyond mainstream media to truly understand the implications of the issue. My research has led me to information about the Roe vs. Wade case. Originally, it was passed in 1973 and was overturned nearly fifty years later. This reversal caused much discontent among American citizens as the ramifications were misunderstood. For example, the Supreme Court's liberal justices commented saying, "With sorrow for this Court, but more for the millions of American women who have today lost a fundamental constitutional protection." However, this statement is incorrect. The reversal of Roe vs. Wade actually returned constitutional rights to the states. Abortion is not illegal nationwide, instead, each state has the right to choose its stance on the issue. This is beneficial because it returns the choice to the American people, which is the entire foundation of our democracy. As American politics continue to polarize, such controversial decisions should not be made on a federal level, instead we should seek out ways to allow states the freedom to decide for themselves.

As we live in the days immediately following the reversal of the Roe vs. Wade court case, my generation faces the challenge of interpreting the Constitution to its original intent. Additionally, we must choose to read past the blaring headlines and discern the real implications of the issues at hand.

I was scrolling through social media one day, and I came across this:


In this Texas heat, it is typically hotter inside than it is outside. On this particular day in Houston, the high temperature was recorded as 101 degrees-and that was without the applied heat index. I could not wait another second; I was moved to act on behalf of this mother and her daughter. As Believers, we have to remember that we, ourselves, can be the answer to someone's prayer...the difference-maker in

someone's day turning around for the better. I immediately placed a call to Sir Knight Frederick "THE FRED" Walker, Sr., who serves as the Eminent Grand Captain General for the Grand Commandery, because this mother lives not far from his neighborhood. I asked him for a recommendation for an HVAC Technician. Without thinking about it, he recommended this guy:



While in conversation with Mr. Simpson ("Simp," as he wanted to be called), I learned that he knew a few Prince Hall Masons in the greater Houston area. I shared the issue with him, and he sent a couple of his best technicians to the residence for an assessment on the same day. This trip to the mother's house would be the third for her, because several HVAC technicians had visited her house, and she was told that several issues were contributing to the malfunctioning unit. "Simp" confirmed later that the unit's evaporator coil had "breathed its last breath" and that it needed to be replaced. A good HVAC technician will tell you that a job of this magnitude generally costs from three to four THOUSAND DOLLARS. "Simp" offered to complete the job for a huge fraction of that cost, bringing it down to \$2,300. Well, if you get an offer like that, you had better act on it immediately before it slips away.

Before the first donated dollar was given, I lifted up all donors in prayer, asking God Almighty to bless the seed that was to be sewn for the purpose of bringing relief to this family. I put out the call to the Sir Knights of the Lone Star Grand Commandery and the Princesses of the Lone Star Grand Guild. In 24 hours, just over half of the amount was raised, and within the ensuing 24 hours after that, the goal had been reached. "Simp" was informed that the donations were rolling in, and he had set a course for the malfunctioning unit to remove and replace it.



The HVAC crew took a whole day and a half to complete the job, which entailed outside work and work in the attic (and we know that the attic heat is even hotter than the outside temps). The end result was a working air conditioning system and much cooler temps inside the house.

This was a monumental effort not only by

the Sir Knights and Princesses of the Lone Star Templar Family, but it should be noted that family and friends of Lone Star also made donations to get the job done. It is just another example of "Working Together Works." I believe that prayer moves the hands that rule the world, and I am eternally thankful to the Lone Star Family and friends for making the decision to be those hands and see God's blessing come to fruition. I am happy to report that the final post looked like this à THANK YOU FATHER GOD for EVERYONE who prayed for us, who called/messaged me with suggestions/recommendations, who opened their homes to us, or offered to send us to a hotel, who sent someone they knew to assess what needed to be done, who actually came and completed the job, and those who made monetary contributions! ### *For those of you that travel a lot…* 10 Things That Lead to Digestive Problems While Traveling

HOUSTON, TEXAS – Dealing with the occasional bout of diarrhea or constipation is never fun, but the most inopportune time to experience digestive problems is while traveling.



"Traveler's diarrhea is the obvious example," says Dr. Eamonn Quigley, a gastroenterologist at Houston Methodist. "But this usually thought to be limited to travel in certain areas of the world where gastroenteritis risk is high."

It's certainly something to know about and take steps to prevent, but Dr. Quigley points out that diarrhea while traveling can occur anywhere and be completely unrelated to infection. "What most people don't realize is that constipation is actually the more common gastrointestinal phenomenon that arises during travel," says Dr. Quigley. "The No. 1 reason for occasional constipation is travel."

These aren't the only two GI problems that seem to arise. You might find you're more likely to get heartburn while away from home. Flying might leave you feeling bloated and gassy. And we're likely all familiar with the nausea that can sometimes accompany a car, boat, or rollercoaster ride.

All to say, the digestive system seems particularly sensitive to travel and its related activities. But why? And are there steps you can take to make sure your bowel movements stay regular and stomach remains settled while on a trip?

### 10 causes of stomach problems while traveling

"There are several things that can lead to digestive issues while flying, specifically, and traveling in general," says Dr. Quigley. "And people prone to constipation, diarrhea and other GI issues might be more easily triggered by these factors."

An important note: They can also be additive, meaning these factors can compound on top of one another to make problems more likely.

The reasons for experiencing stomach issues while traveling include:

#### 1. Dietary changes

Our diet and eating habits often look different than usual while traveling. Away from home, we're less in control of what we eat and when we eat. We might treat ourselves to snacks and desserts more frequently on vacation.



"Maybe we're eating fewer vegetables and therefore getting less fiber, which can lead to constipation," says Dr. Quigley. "Or sometimes we're trying entirely new cuisines and we inadvertently eat something we're intolerant of and diarrhea or indigestion result."

Not overeating and maintaining a balanced diet as much as

possible can go a long way toward avoiding these fates. But that's not always totally realistic during travel, especially when you're trying to enjoy your vacation. This is where Dr. Quigley recommends knowing which over-the-counter medication to take if you do experience a digestive issue.

- · Anti-diarrheal medications (loperamide, bismuth subsalicylate) can help reduce the frequency of watery, loose stools.
- Oral laxatives and stool softeners (polyethylene glycol, docusate sodium) can help alleviate constipation.
- Antacid pills can help with heartburn, indigestion and upset stomach

Be sure to take these medications according to the package instructions.

#### 2. Stress



The stress of travel can begin soon after you leave the house: Making sure you don't miss your flight, navigating a crowded airport, needing to evacuate your bowels in a bathroom you share with people sometimes sitting inches away from you.

"Stress influences bowel function, which can go either way - constipation or diarrhea," says Dr. Quigley. "All you have to do is think back to that important exam you had in college to remember how stress can make bowel 58 movements more frequent or loose. But stress can also lead to incomplete bowel movements in other scenarios."

Back to that cramped, shared bathroom on a plane: The ensuing stress can prevent a person from having a complete bowel movement, which can contribute to constipation. Plus, when constipated, people tend to fixate on the issue, notes Dr. Quigley, adding to the stress and making the constipation worse.

Here again, there's not always a lot you can do — travel is just stressful sometimes. But the same advice as above applies: If you do experience diarrhea or constipation while traveling, the right over-the-counter remedies can help relieve it.

### 3. Dehydration

Being dehydrated is a risk factor for constipation, but drinking enough water while traveling can be tricky.

Bathroom breaks can be time-consuming on a long road trip or tricky to accommodate in certain locations, leading you to purposefully drink less water. In addition, a supply of water isn't always readily available while traveling — or that supply might not be safe.

Dr. Quigley stresses the importance of having a hydration plan while traveling, whether that's bringing a water bottle you can fill yourself or knowing where to buy sealed water that's safe.

### 4. Alcohol consumption

"We should hydrate with water, not alcohol," Dr. Quigley adds. "Whether it's a drink before a flight or at lunch between sightseeing, know that alcohol is not hydrating." In fact, alcohol is dehydrating — and remember, dehydration is a risk factor for constipation.

### 5. Barometric pressure changes

"Airplanes have pressurized cabins, but they're not completely pressurized," says Dr. Quigley. "The greater the difference between the pressure in the atmosphere and that in your body, the more the air in your stomach is going to expand — and that's why you begin to feel bloated while flying."

Bloating is annoying enough on its own, but if it persists, it can also contribute to constipation.

"The longer the flight, the more noticeable the issue can become," says Dr. Quigley. "Studies show that long-haul cabin crews experience more gut disruptions than short-haul crews."

Now is a great time to point out just how additive some of these factors can be, especially with certain types of travel. For instance, flying is often a triple whammy — stress, dehydration and pressure changes are a recipe for experiencing constipation while traveling if you're not careful, especially <u>if you're already prone to it</u>.

"Add to that the carbonated diet soda you have before or during your flight, which only makes bloating worse," says Dr. Quigley.

#### 6. What you eat and drink before a flight



The gassier your meals and beverages are before a flight, the more likely you are to get bloated and constipated.

"Avoid eating foods that are most likely to cause gas, like onions and garlic, for about 24 to 48 hours prior to flying — since these take quite a while for your body to completely digest," says Dr. Quigley.

Carbonated soft drinks and sparkling waters are another cause of bloating. In some people, they can also trigger indigestion while flying. But since liquids pass through the body quickly, they're typically only an issue when consumed shortly before boarding a flight.

#### 7. Traveler's diarrhea

Traveler's diarrhea — a type of gastrointestinal infection — occurs when a person gets ill from food or water that's contaminated with a virus, bacteria or parasite. The primary symptom is indicated by the name, but traveler's diarrhea can also cause abdominal cramping, vomiting and even fever, if the infection is bad enough.

"This is more common when traveling to certain areas of the world where the risk of gastroenteritis is high," says Dr. Quigley. "This is something you should research before your trip."

Tips for preventing traveler's diarrhea if you're traveling to a risky area include:

- Only eat food that's been cooked to the appropriate temperature.
- Avoid eating raw foods, particularly salads.
- Only drink filtered water from a sealed container.
- Avoid adding ice in your drinks.
- Travel with ciprofloxacin if you have a GI condition that makes you prone to diarrhea (to take only if you experience an infection).

### 8. Disruption of your biological clock

When travel takes you across time zones, it can impact your circadian rhythm — your body's way of setting and timing its internal clock.

"There's diurnal variation in a lot of the body's physiological processes, colon motility included," explains Dr. Quigley. "At nighttime, our colon goes to sleep with us. In the morning, our colon wakes up and we see a big increase in activity."

But when what's 10 p.m. to your internal clock is actually 8 a.m. in your new location, colon confusion ensues. This can contribute to GI issues, namely constipation.

"Changing your internal clock by a few hours isn't a big deal, but 10, 15 hours — that's a significant change that can really disrupt your body's rhythm," says Dr. Quigley. "This can lead to irregular colon motility and contribute to constipation."

### 9. Forgetting to bring your medications if you have a known GI issue



It might seem obvious, but Dr. Quigley points out that forgetting to pack medication you take for an existing issue is a common way to end up with digestive problems on a trip.

"Whether it's an over-the-counter acid blocker for acid reflux, daily oral laxative for treating constipation or a prescription medication for colitis, we hear about this all the time," says Dr. Quigley. "And once you do realize you've forgotten your

medication, finding a replacement isn't always straightforward."

If you're traveling to another country, trade names of products can differ, and filling prescriptions certainly isn't always a guarantee.

Dr. Quigley also points out that people prone to constipation, in particular, shouldn't be afraid to increase their meds.

"Especially if the person has a history of their constipation worsening with travel, we often recommend they prepare by taking an additional dose of laxative," says Dr. Quigley. "People are often afraid to increase their laxative dosage for fear of becoming dependent, but they needn't be reluctant to do so."

### 10. Being unprepared for motion sickness

Motion sickness, also sometimes called travel sickness, may not be something you think about often, but it might be important to consider when making your travel plans — especially if you don't know how you'll react to a type of travel known to cause motion sickness, like cruise ships.

"This isn't actually a digestive problem, but the symptoms can be related to the digestive system — nausea and vomiting," says Dr. Quigley.

Over-the-counter remedies can help alleviate motion sickness, but there are also strategies for preventing it if you're prone, like keeping your eyesight on the distant horizon when on a boat.
